

### *Tacoma Lariettes Halloween Show Health Protocols*

**To All Exhibitors/Guests/Family members/Vendors in areas of the Tacoma Unit #1 Property. The following guidelines have been put in place in accordance with the recommendation of the CDC and State Health guidelines regarding social distancing and public health.**

Exhibitors are asked to refrain from attending the show if they have been in contact with anyone exhibiting COVID-19 symptoms with-in the last 14 days, have a fever or other symptoms, or are immune compromised.

New Updates as of 8/10/2020 Proclamation 20-25 Agriculture Events:

Due to the recent mandates put in place by the Governor, Face mask/shields are MANDATORY! **Please always keep a face mask or face shield on at all times or with you.** Face masks and gloves will be available if needed. Hand sanitizers will be placed in locations all the over the TU

Due to the most recent Governor restrictions, no group larger than 5 may stand together and the distance between those groups of 5 or less must be 15 feet apart. Everyone needs to stay within your own group. To have this show we have agreed to the Governor's mandate that everyone will follow this mandate. **NO EXCEPTIONS!!!!**

Volunteers may ask (or remind) small gatherings to maintain social distancing; please treat the volunteers with respect.

Every exhibitor or parent of a minor exhibitor, MUST sign a liability release before being allowed to pick up their back number. Outside spectators and vendors are NOT allowed to attend.

Exhibitors are required to complete all paperwork online. All stall and RV reservations will be handled online as well. Exhibitors are asked to sign up for every class you might think you are wanting to enter. Form of payment will be credit card. Cash is discouraged.

Essential personnel for each horse, such as Exhibitors/assistants/family members/vets/farriers are the only people outside from the exhibitor and horse/mini/pony that can be on the grounds at the Tacoma Unit.

Only Show staff or volunteers will be allowed in the Announcer's booth and the Show office. The Show office will be limited to ONE person PER staffed window. We will have a 6-foot social distancing marker for exhibitors are to wait for their turn. Please be respectful toward all office staff and volunteers while we work thru all these changes.

The main office door will be an ENTRANCE ONLY. Exhibitors will be required to exit to the back door of the office and then out the side door exit in which you will be required to walk around the building, entering into the arena is not allowed. The office entrance and exit doors will remain open to keep the touch zones under control. We will be cleaning high touch areas multiple times a day.

All show staff will have their temperature taken each morning and a log will document if it is higher than 99.5 F they will not be allowed to enter and sent home.

Hand sanitizers will be placed in all high traffic areas and we ask that you use it every time to enter that area. Portable hand washing stations will be available outside each barn, by the office area and off the 176th warm up arena.

Arena entrances/exits will be arranged so that riders are not coming in close contact entering and exiting the arenas. Riders to follow the direction of the volunteer for entering/exiting. Loitering is not allowed around the in or out gates.

There is 50 people MAXIMUM allowed to be in the arena at one time. That includes, those in the viewing area and exhibitors. If the 50 persons limit is exceeded, we will ask those in the viewing area to leave first.

Announcer, ring steward and staff is not included in the 50 person limitations.

Once the contestant is on horseback, face coverings are not required. All others are required to wear a mask or face shield.

Riders shall always maintain social distancing guidelines including, but not limited to, the warm-up arena and show arena, bathrooms, and office area.

Please Respect the gate person(s) personal space and maintain proper social distancing when interacting with them. Always wear a mask when approaching ANY staff member.

Warm up areas in the arenas are limited to the rider and trainer, except lead line area allowed one additional person, no gathering at the ingate or out gate, all foot traffic must go to the approved viewing area to watch.

**IF** the 176th side of the arena viewing area is open, you must follow all state required protocols of no more than 5 in a group sitting together, wearing masks and preferably social distancing, the next group must be 15 feet apart. The viewing area is only for exhibitors, parents of minor exhibitors or owners. NO OUTSIDE SPECTATORS ARE ALLOWED.

Separate entrance and exit door will all be marked in the show office, bathrooms, and the arena seating area. Please follow all the marked exits.

All Class Placings and High Points will be posted on the premises.

Ribbons and awards will have a designated location and time for awards to be picked up and will be announced. We will not be accepting returned ribbons at the end of the show.

The announcer's booth, tables, seats, and microphones shall be wiped down routinely.

No exhibitor gatherings with food/banquet style/ or have food left on tables in the aisleways in the barn areas. Only the Horse Play Café will be open for food and beverage sales.

The bathrooms and portable bathrooms, along with high traffic areas will be closed several times a day for additional cleaning.
